Wool and hair must be produced from animals from a third country or region thereof as listed in a document relating to 'fresh meat of ungulates' published on GOV.UK, in accordance with Commission Regulation (EU) No 206/2010^(†) and authorised for imports into Great Britain of fresh meat of ruminants not subject to supplementary guarantees A and F mentioned therein.

Wool and hair must be produced from animals kept in the third country or region thereof free of foot-and-mouth disease and, in the case of wool and hair from sheep and goats, of sheep pox and goat pox in accordance with the basic general criteria listed in Annex II to Directive 2004/68/EC.
